Awareness and Registration drive for Labour Cards for Construction Workers in Shankarpally Mandal, Ranga Reddy District, Telangana

The Legal Aid Society of ICFAI Law School, IFHE, Hyderabad, launched a registration drive for labor cards for construction workers on November 7, 2024. The registration is conducted under the Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996. Every building and construction worker registered as a beneficiary under this Act is entitled to various benefits provided by the Telangana Building and Other Construction Workers Welfare Board.

With this labor card, workers can access benefits such as marriage gifts, maternity benefits, fatal accident relief, disability relief (both total and partial), natural death relief, hospitalization relief, funeral expenses, skill development training, vocational training for dependents, relief for unregistered workers, and disability aids and appliances.

Legal Aid members have informed construction workers about available social security benefits and assisted them in completing Form 27 for registration and biometric verification. This registration drive will continue on November 8th and 9th, 2024. Each construction worker is required to pay Rs. 230 for registration; however, we charge an application fee of Rs. 110. The ICFAI Law School Alumni Association (Batch of 2024) will sponsor the remaining Rs. 120 per worker, which covers processing, printing, and lamination of the card. We expect a minimum of 200 registrations. This initiative is being conducted in collaboration with the Mandal Legal Services Authority in Ranga Reddy District and ANKITA NGO. The event is coordinated by Dr. S. Kannan and the Legal Aid members of ICFAI Law School, IFHE, Hyderabad.

The Legal Aid Society of ICFAI Law School, IFHE, Hyderabad, has initiated a dedicated registration drive for labor cards targeting construction workers in Shankarpally Mandal, Ranga Reddy District. Launched on November 7, this initiative aligns with the Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996, and aims to provide construction workers with access to a range of social security benefits offered by the Telangana Building and Other Construction Workers Welfare Board.

By registering as beneficiar-

ies under this Act, workers become eligible for benefits such as marriage gifts, maternity benefits, fatal accident relief, relief for both total and partial disabilities, natural death relief, hospitalization assistance, funeral expenses, skill development programs, vocational training for dependents, and disability aids and appliances.

The Legal Aid Society has been instrumental in raising awareness about these benefits, guiding workers through the registration process, and assisting with the necessary documentation and biometric verification through Form 27.

Each construction worker contributed Rs.110 toward the application fee, with an addi-



tional Rs.120 provided by the ICFAI Law School Alumni Association, Batch of 2024, to support their registration.

This drive, which will continue for two additional days, is being conducted in collaboration with the Mandal Legal Services Authority of Ranga

Reddy District and the NGO ANKITA. Dr. S. Kannan, along with Legal Aid members from ICFAI Law School, has coordinated the event, actively working to ensure construction workers in the region are informed and registered to receive these vital benefits.
