Population Dynamics World Population Day 2021

World Population Day is observed on July 11 and is dedicated to focusing on the importance of population issues. Today the world population as per current statistics is 7.9 billion - as of July 2021. On this date, vis-a-vis, 11th July in 1987, the world population reached five billion, Hence since then, we are observing 11th July of the annual calendar, as World population Day.

World Population Day serves to highlight the problems that come with the rapid growth of the global population. Overpopulation is a crucial issue, especially considering the inadequate world resources which are depleting due to low production and unsustainable behaviour. Awareness about the effects of overpopulation on development and nature is to be emphasized.

The issue of expanding population is causing strain on society, leading to heinous crimes that are happening in regular and especially in the vulnerable, related to gender inequality and suppression of human rights, especially in developing countries.

Every year there is a specific theme for World Population Day and the theme of World Population Day for the 2021 year amid the pandemic is "Rights and choices are the answer: Whether baby boom or bust, the solution to shifting fertility rates lie in prioritizing the reproductive health and rights of all people."

The projections are indicating a rise in the proportion of people aged 65 and above in every major region of the world, it is expected to rise from 5 to 15 per cent in the developing regions and from 14 to 26 per cent in industrial regions.

At the time of Independence India's total population was around 370 million and an Indian woman on average had six children. The Age structure was young and more than 80 per cent of the population were illiterates. As a consequence population grew rapidly in the 1960s Ford Foundation Commissioned the **"Second India"** Before the year 2000 it reached 1 billion marks.

In summary, India's demographic evolution over the coming decades will provide a potential boost to its rate of economic growth – at a time when China will be losing the demographic impetus that has helped spur its economy. But the process is not automatic. Policy choices in the areas of governance, macroeconomic management, trade, and human capital formation can have a significant effect on the realization of the demographic dividend.

While these are all excellent policies independently of demographics, the stakes are much greater when a large cohort is poised to enter the working ages. Given its high levels of internal heterogeneity, India needs to consider a combination of these approaches and policies to catalyse and speed its demographic transition and to capture a demographic dividend.


