Eligibility:

- Graduation in Five Year Integrated / Three Year Law or equivalent Degree recognized by The Bar Council of India with a minimum of 50% Marks or equivalent CGPA.
- Should have qualified in the ILSAT (PG) 2026 conducted by ICFAI Law School, IFHE, Hyderabad.
- The students appearing for final year examinations and awaiting results may also apply for the ILSAT (PG) 2026.
- The admission however, remain provisional until they produce mark sheets establishing their eligibility.
- The last date for submitting the proof of eligibility is **September 18, 2026**, failing which the provisional admission will automatically stand cancelled.

Eligible applicants are required to apply for the program.

All admissions will be subject to verification of facts from the original certificates/documents of the students. The decision of the Admissions Committee regarding eligibility and admission of applicant shall be final.
