### The Pinnacle of Advocacy

### Shri N.J. Yasaswy Memorial 10th Moot Court Competition, 2025 Inaugural Ceremony

The ICFAI Law School, IFHE, Hyderabad, successfully organized the Shri N.J. Yasaswy Memorial 10th Moot Court Competition, 2025, from 29th to 31st August 2025 at the IFHE campus, Dontanapally. The three-day event witnessed the enthusiastic participation of 37 teams from premier institutions across the country, including National Law Schools. The competition was structured around two moot propositions—the first for the preliminary rounds and quarter-finals, and the second for the semi-finals and finals—providing a rigorous and intellectually stimulating platform for students to demonstrate their research, reasoning, and advocacy skills.

The Inaugural Ceremony commenced with a warm Welcome Address by Dr. Himavathi T, Faculty Coordinator, Moot Court Society, followed by the Presidential Address delivered by Prof. Ravisekhararaju, Director, ICFAI Law School, who reaffirmed the institution's commitment to experiential learning in legal education. Prof. Y. Pratap Reddy, Dean, enriched the occasion with his introductory remarks.

The ceremony was graced by Hon'ble Shri Justice Narsing Rao Nandikonda, Additional Judge, High Court for the State of Telangana, who attended as Chief Guest. #### **Crossword Conquest**






# Faculty Corner
