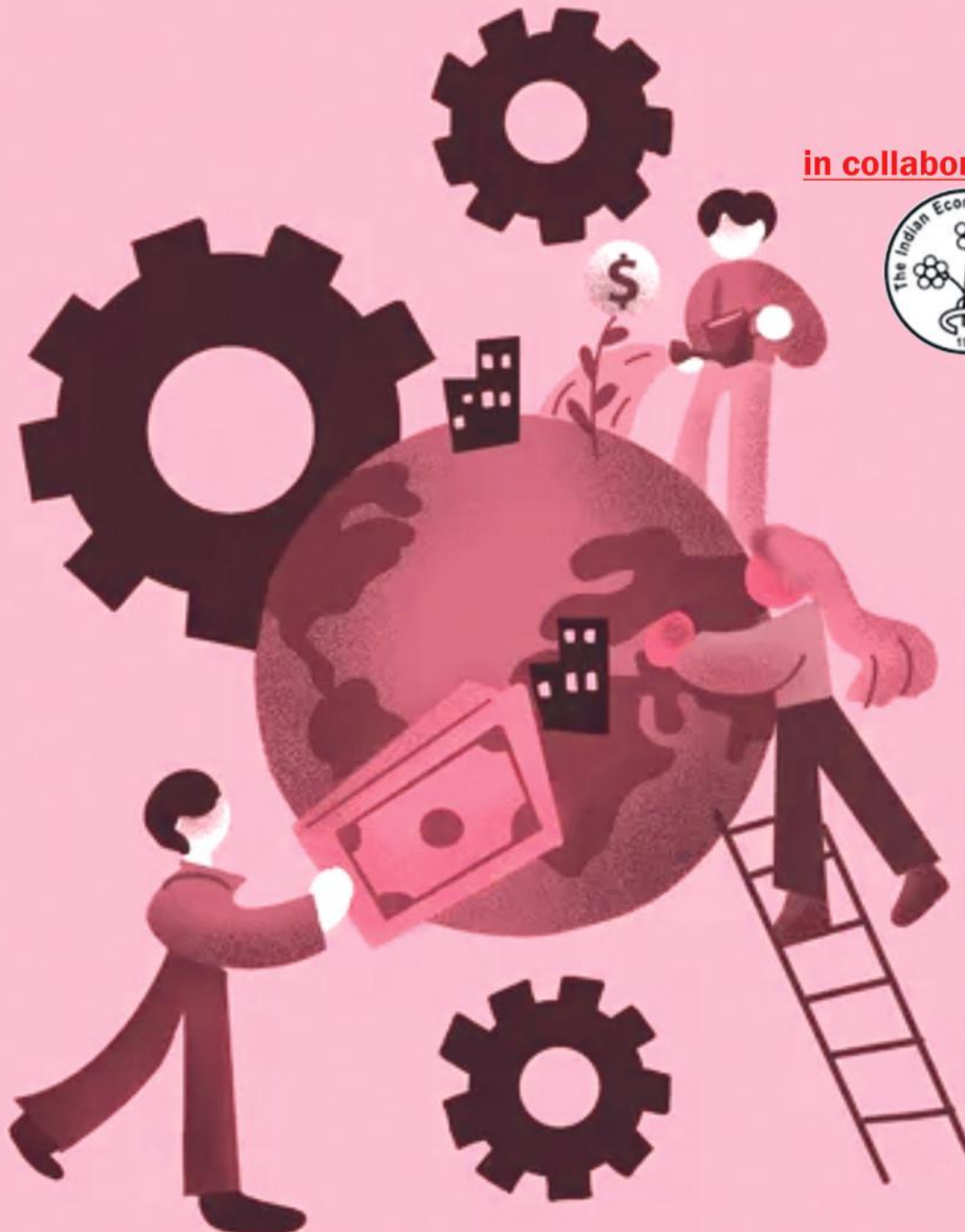

## **About ICFAI School of Social Sciences (ISOSS)**

## Submission Guidelines

- The papers submitted to the ICAE Conference should not have been published or sent for publication or presented in any other Conferences.
- Contributors are advised to follow the UGC Guidelines for the maintenance of standards and plagiarism.
- The full paper should be in word format and emailed to [icae@ibsindia.org](mailto:icae@ibsindia.org)
- Papers submitted for the conference should be in English, in Times New Roman font, size 10, and typed in double space.
- Two members of the Review Committee will review the paper. The name and affiliation of the author(s) will be removed before the paper is sent to the Review Committee.

- With the submission of the paper, the following items should be included on the first page:
  - Cover page showing the title of the manuscript, the name, affiliation, and full address of the author/s with e-mail ID, including acknowledgment if any.
  - Abstract of up to 300 words, five or fewer key words.
- Section headers should be left justified with Arabic numerals. Only the first word should be capitalized. Headers should be in bold face, and subheads in italics.
- Mathematical Notations, Tables, and Figures should be clearly explained within the text.
- Foot Notes and References should be incorporated into the text. Footnotes in the text must be numbered sequentially and they should follow the reference section.
