Dr. M. Govinda Rao



Dr. M. Govinda Rao is an Emeritus Professor, National Institute of Public Finance and Policy, New Delhi. Presently, he is a Member, Board of Governors, Institute of Economic Growth, New Delhi and Member, of the Governing Body of Madras School of Economics. He was a Member of the Fourteenth Finance Commission, Government of India. His past positions include Director, National Institute of Public Finance and Policy, New Delhi (2003-13), Director, Institute for Social and Economic Change, Bangalore (1998-2002), and Fellow, Research School of Pacific and Asian Studies, Australian National University, Canberra, Australia. He has done extensive research on various aspects of public finance and development and authored 19 books and monographs and over 120 research articles in refereed journals. His most recent publications include Growth and Development Performance of States in India (co-author: Arvind Panagariya; Oxford, 2014) and Making Miracles in Indian States (co-editor: Arvind Panagariya; Oxford, 2015).

Mr. Devendra Surana is currently the Managing Director of Bhagyanagar India Limited and Director of Surana Ventures Ltd. He is the Chairman of Telangana State Council, FICCI. His classes apply economic analysis to contemporary business and public policy issues.
