SC Recent Judgment

Himachal Pradesh Bus Stand Management and Development Authority (HPBSM&DA) v. The Central Empowered Committee Etc. & Ors., Civil Appeal Nos. 5231-32 of 2016.

Brief Facts

Ministry of Environment and Forest (MoEF) by its orders dated 12th November, 1997 and 1st March, 2001, permitted the diversion of 0.093 hcts and 0.48 hcts of forest land for the purpose of construction of parking space and bus stand respectively at the McLeod Ganj on a proposal submitted by the State of Uttar Pradesh. The land so diverted shall be subject to the compensatory afforestation of 250 trees, minimum of not exceeding 17 trees can be felled and the lands will be used only for the purposes mentioned in the proposal. The appellant authority was constituted in April 2000.

In contravention of the above mentioned permissions by the MoEF, for parking space and bus stand at McLeod Ganj, additional structure of Hotel-cum-Restaurant was raised without the approval from the Town and Country Planning Department (TPC). TPC further have halted such construction but still the constructions were completed.

During the construction, sixth and seventh respondent applied to CEC complaining about the violation of the Forest Act.

CEC Recommendations

Members of CEC after investigating and hearing the parties have given the following recommendations:

- a) The hotel structures must be pulled down immediately and the forest land to be cleared of debris within three months.
- b) Parking place may be constructed as originally visualized with the prior approval of the Town and Country Planning Department.
- c) State Government may constitute a Committee with the Chief Secretary as Chairman with the Principal Chief Conservator of Forests, Senior most Engineer in the State of PWD and a representative of MoEF as members.
- d) The Committee would, in time bound manner propose the efficient use of the bus stand and ensure maximum parking place for the vehicles.

NGT Proceedings

Supreme Court transferred the case to NGT on an application being filed by the second respondent to set aside the report of the CEC as the principles of natural justice have not been followed.

The NGT accepted the findings of the CEC, observing that the Bus Stand Complex seriously disturbs the ecology of the area in which it has been constructed. The NGT directed, inter alia, that:

i) The structure of the Hotel-cum-Restaurant in the Bus Stand Complex be demolished by the second respondent;

- ii) The second respondent shall pay a compensation of Rs. 15 lacs in terms of Sections 15 and 17 of the NGT Act;
- iii) The appellant shall pay a compensation of Rs. 10 lacs, while the State of Himachal Pradesh and its Department of Tourism shall pay a compensation of Rs. 5 lacs each; and
- iv) The Chief Secretary of the State of Himachal Pradesh shall conduct an enquiry against the erring officers of the appellant, in order to fasten the responsibility for the illegal project.

Supreme Court decision in the present Appeal

"We uphold the directions which have been issued by the NGT in its judgment. By the earlier orders dated 16 May 2016 and 9 September 2016, this court only stayed NGT's direction in relation to the demolition of the Hotel-cum-Restaurant structure. The appellant has tried to argue against the demolition of the Hotel-cum-Restaurant structure in the Bus Stand Complex, submitting that it may be allowed to stand for their use. However, we cannot accept this submission. Doing so would legalise what is an otherwise entirely illegal construction.


Hence, we direct that the process of demolishing the Hotel-cum-Restaurant structure in the Bus Stand Complex be commenced within two weeks from the date of the judgment and the structure shall be demolished by the second respondent within one month thereafter. In the event of default, the Chief Conservator of Forest along with the administration of district Dharamshala shall demolish the structure and recover the cost and expenses as arrears of land revenue from the second respondent.

Further, as directed by the NGT, the State of Himachal Pradesh and the second respondent can utilize the parking space and the bus stand in the Bus Stand Complex, after the demolition of the Hotel-cum-Restaurant structure. However, this has to be in accordance with orders dated 12 November 1997 and 1 March 2001 issued by the MOEF, i.e., it shall not be used for any purpose other than parking of cars and buses, as the case may be."

Compensation for Environmental Damage under International Law - 1st Edition, January, 2020

It examines a wide range of practice on compensation - in general and specifically for environmental damage - from that of international courts and tribunals, as well as international commissions and regimes, to municipal approaches and other disciplines such as economics and philosophy. Compensation for Environmental Damage Under International Law synthesizes these approaches with a view to identifying their blind spots, bringing clarity to an area where there exists broad discrepancy, and charting best practices that appropriately balance the manifold interests at stake. In particular, it is argued that best practice methodologies should ensure compensation serves to fully repair the environment, reflect the emerging ecosystems approach and any implications environmental damage may have for climate change.
