Guidelines for paper submission

Submissions for presentation in the conference are to be mailed the form of an abstract of 500 words and full research papers (Not less than 5000 words) with footnotes in bluebook 20th edition format. The research paper is to be typed in Font Times New Roman with font size 12 and line spacing 1.5, headings to be typed in font size 14 Bold and footnotes in font size 10.

The abstract should be of 400-500 words with minimum five keywords and must be accompanied by a cover page consisting of the author's details.

Conference Proceedings and Publication

All the accepted full research papers submitted before deadline will be published in a book form with ISBN number. The presentation of accepted research paper is mandatory for the purpose of publication.
