

Under the aegis of the Centre for Excellence in Cyber Law and Data Protection Laws, the event aimed to enlighten participants about the dynamic applications of Artificial Intelligence (AI) in healthcare and its future trajectories.

FRIEDEN, the ADR Club of ICFAI Law School, IFHE, Hyderabad, organized a webinar on 07.02.2024 addressing "The role of ADR in family matters: Resolving Disputes Amicably."Dr. Karuna Malviya, Director of D.Y. Patil Deemed to be University and a Senior Research Fellowship awardee by the UGC, served as the resource person,



offering insights into thetopic. The session commenced with Dr. Prof. Y Pratap Reddy, Dean of ICFAI Law School,IFHE, Hyderabad, delivering introductory remarks. Dr. Reddy emphasized the significance of ADR, its necessity, and its relevance in resolving family disputes within the current legal frame work. He underscored the objectives behind the enactment of the Family Courts Act,1984, highlighting its expeditious dispute-resolution mechanism concerning family matters, Particularly those related to marriage and families affairs. Dr. Malviya delineated the scope of utilizing ADR in various family matters, including therestitution of conjugal rights, testamentary and intestate property rights issues, and childcustody matters. She emphasized that not all family disputes can be efficiently addressed through conventional court processes, necessitating the intervention of ADR practices forswifter, cost-effective, and mutually agreeable solutions. Dr. Malviya referenced the landmark judgment in Jagannath's case, wherein the court recognized the pivotal role of ADR under Section 23 of the Hindu Marriage Act, as well as the Commercial Courts Act and the Legal Services Authority Act. Additionally, she addressed inquiries raised by student participants and shared her professional experiences as a certified mediator.

## One Day Training Programme On LGBTQIA+ Allyship and PoSH

#### One Day training programme on LGBTQIA+ Allyship and PoSH was organised by the Centre for Gender Studies, ICFAI Law School, Hyderabad, in collaboration with the US Consulate General, Hyderabad; Washington State University, USA and POSH at Work, "SYNERGIZING THE GENDER TASK FORCE: ILM-o-AMAL (Inclusion and Leveraging of the Movement- Accessing and Mainstreaming the Assessment of Legislations)" on 21st February 2024 from 10:00 AM to 4:00PM. The training programme was held in a blended mode with physical and virtual participation of eminent speakers, academicians and professionals from all across the world. The total number of participants for who participated were over 125 including students and faculties. In the beginning of the event Prof. L S Ganesh, Vice Chancellor, IFHE, Hyderabad, gave the introductory remarks. He spoke about the idea of equality and equity and how it affects people in day-today life. Sir said that Equality is not only about gender but also how we move with each other and it is important to recognize the artificially drawn lines of classification. 

The Allies are more effective and powerful voices of the LGBTQIA+ movement. They help people to come out and express themselves help others whose knowledge about LGBTQIA+ people is inaccurate, support their members, and address acts of discrimination.

He then trained the participants on how to be allies to the LGBTQIA+ community by indulging them into various situations and case studies. The third speaker was Adv. Shivangi Prasad, Lawyer, Author, Founder-The Legal Swan, PoSH at Work & Samp; Respekt-LGBTQ+Ally President, ASHC(Mah), WICCI, G100, Child Care, Advisory Country Chair. She addressed the students about the importance of the POSH Act. She specified that there should be an internal committee that should inquire into the complaints and should consist of members who are outside the organization. She mentioned the UGC Guidelines on Sexual Harassment which are genderneutral whereas the PoSH Act is only for women. The trainees were made aware of legal concerns pertaining to sexual harassment and were educated about gender biases that bring about gender inclusivity and eliminate unconscious bias at workplaces. In the end Prof. Dr. S. Vijaya Lakshmi, Registrar, IFHE, Hyderabad gave Concluding Remarks.
