#### Eligibility:

- Graduation in Five Year Integrated / Three Year Law or equivalent Degree recognized by The Bar Council of India with a minimum of 50% Marks or equivalent CGPA.
- Should have qualified in the ILSAT (PG) 2024 conducted by ICFAI Law School, IFHE, Hyderabad.
- The candidate should have enrolled himself as an advocate for a period of at least one year and should have working experience minimum of 2 years in any law firm or corporate legal department.
- The admission however, remain provisional until they produce mark sheets establishing their eligibility.
- The last date for submitting the proof of eligibility is **September 17, 2024**, failing which the provisional admission will automatically stand cancelled.

Eligible applicants are required to apply for the program.
