NEWS ITEMS

TENTH CONVOCATION

The Tenth Convocation of the ICFAI Foundation for Higher Education was held virtually on March 10,2021.



During the Convocation 2070 students received their degrees. Out of which 2 students were conferred their Ph.D degrees, 1181 students awarded MBA degrees. In the other streams, 4 LLM,84 BBA-LLB (Hons), 141 B.Tch and 574 BBA degrees were awarded. MMS degrees were awarded to 84 students.

Dr C Rangarajan, Chancellor of the University, presided over the function and delivered the Convocation address. Congratulating the graduating students, Dr Rangarajan said, "This is an occasion for celebrating for all of you, as your academic efforts have come to a successful fruition. As you enter a new stage in your life, your future is intertwined with the future of this country. But, at the same time, you have the opportunity to shape it. Youth is

full of idealism and ambition. Idealism without ambition may not achieve much. On the other hand, ambition without idealism is dangerous May you combine the two in the right proportion!". Commenting on the state of the economy, Dr Raangarajan said "If on ly the Indian economy grows at 9.7 per cent in 2021-222, will be compensating for the decline in 2021-21. We will then be where we were at the end of 2019-2020. As the saying goes 'we need to run fast to stay where we are'. The recent Budget has projected the growth rate for 2021-22 at 10.5 per cent. It sounds little optimistic. We as a nation really need to organize ourselves to get back to the high growth path as early as possible".

He added, "looking at the recent discussions on agricultural marketing reforms, the best course of action for the central government now may be to leave to each state to decide whether they want these measures or not. That will set the stage for experimental economics and farmers themselves will be able to se the best possible course of action with respect to agriculture marketing reforms."

Prof J. Mahender Reddy, Vice Chancellor, highlighted the University's endeavors towards promoting online education during the COVID -19 PANDEMIC. He said the transition from offline to online has been smooth and that the faculty, students, and support staff have adapted to this change quite well. Prof Reddy informed that the UGC Expert Committee has recommended approval of the 12-B status to the University. With the ratification by the UGC, the University becomes eligible to receive financial assistance under all UGC and Government schemes for research and teaching.

New 48 Chief Justice of India

Justice NV Ramana took oath as a the New Chief Justice of India on April, 24.2021. He was administered the oath by President Ram Nath Kovid at Rashtrapathi Bhavan. Prime Minister Narendra Modi, Vice President Venkaiah Naidu along with other dignitaries were present at the ceremony. Justic Raman was bon on August 27, 1957, will have a tenure as India's chief justice for a year and four months, till August 26, 2022. Raman, Who will take over as a India's 48th Chief Justice, hails from the Krishna District of Andhra Pradesh and has been in the legal circles since the early 1980s. Before becoming part of the apex court, Justice Ramana Practiced Civil, Criminal, Constitutional law at the Andhra Pradesh High Court, Central Administrative Tribunal, A P state administrative tribunal.

SC Recent Judgment

Ramachnadrapura Math Vs. Sri Samsthana Mahabaleshwara Devaru

Judgment Date: 19-04-2021

The petitioners are before this Court claiming to be aggrieved by the order dated 10.08.2018 passed by the High Court of Karnataka in W.P. No.30609/2008 and connected petitions. The issue raised in the petitions was with regard to the status of 'Gokarna Mahabaleshwara Temple'. A Notification dated 30.04.2003/01.05.2003 was issued under Section 23 of the Karnataka Hindu Religious Institutions and Charitable Endowments Act, 1997 notifying the temples mentioned therein as coming within the purview of the Act.

In the said notification, the 'Gokarna Mahabaleshwara Temple' was also included at Serial No.92. The said position remained so until the petitioners herein claiming to be aggrieved by such notification made a representation seeking that the temple be deleted from the notification since according to them it was attached to the petitioners' 'Mutt' and was therefore not covered by the Act in view of Section 1(4) of the Act, 1997.

VIIT Pharmacy College and Anr. Vs. Dr. A.P.J. Abdul Kalam Technical University and Anr.

Judgment Date: 15-04-2021

The petitioners have approached this Court seeking a direction to the respondent No.1-Dr. A.P.J. Abdul Kalam Technical University (hereinafter referred to as the 'University') to grant affiliation for B. Pharma course to the petitioner colleges for the academic year 2020- 21 with further direction to respondent No.1-University to organize special examinations for B. Pharma students for academic year 2020- 21 in view of the notification dated 19th March 2021.

The facts in brief giving rise to the petition are as under:- On 28th January 2020, the respondent No.1-University invited applications for grant of affiliation for the year 2020-21. In response thereto, the petitioners submitted applications in the month of February 2020 seeking affiliation for B. Pharma course for the year 2020-21.

It is pertinent to note that the Pharmacy Council of India (hereinafter referred to as the 'PCI') granted its approval to the petitioner No.1-VIIT Pharmacy College vide order dated 10th April 2020 for conduct of first year B. Pharma course for the academic year 2020-21 with intake capacity of 100 admissions/students. Insofar as the petitioner No.2- RV Institute of Pharmacy is concerned, a similar approval was also granted; however with the intake capacity of 60 admissions/students. The same was subject to submission of consent of affiliation of Examining Authority and NOC of the State Government.


In the meantime, the respondent No.2-State of Uttar Pradesh came up with the policy dated 15th May 2020 for restricting the number of pharmacy colleges to only two per district. The said policy came to be challenged before the High Court of Allahabad in bunch of petitions being Misc. Single No. 12536 of 2020 filed by Zee College of Pharmacy with companion matters.

The Allahabad High Court vide judgment and order dated 2nd November 2020, relying on the judgment of this Court in the case of Pharmacy Council of India v. Dr. S.K. Toshiwal Educational Trusts Vidarbha Institute of Pharmacy and Others Etc.1 set aside the policy dated 15th May 2020, only insofar as the petitioners who had approached the High Court. The petitioner institutions therein were permitted to participate in the counseling being conducted for admission to Bachelors of Pharmacy course for the academic year 2020-21.

KARMA: A Yogi's Guide to Crafting Your Destiny



In twenty short accounts



of such cases, Justice Chandru recounts how bold and courageous women, by approaching the law for redressed of wrongs done to them, have not only contributed to the fight for social justice, but have broadened and enriched the very meaning of justice. JUSTICE K. CHANDRU Justice K. Chandru is a retired judge of the Madras High Court, famous for his moral rectitude. Among other things, he was one of the first judges to declare his assets to the Chief Justice; he refused to have a red beacon on his official car or a sub-inspector ranked personal security guard; he refused to be addressed as 'My Lord' in court; and surrendered his official car on the morning of his retirement, going home by public transport that evening. He passed many landmark judgments, many in favor of the underprivileged or marginalized sections of society.
